PARENTAL CONSENT, RELEASE FROM LIABILITY AND INDEMNITY AGREEMENT

Final payment due at least 60 days before departure. Checks payable to "Prime Travel". All credit card payments will be charged a three per cent (3%) service charge.

RENTAL CAR: Passenger responsible for gas, tolls, insurance, and all taxes & fees. Renters must be at least 25 (Florida law).

DOCUMENTS: Sent about 10-14 days before trip, on receipt of payment. Overnight delivery fees may apply for late bookings.

GAME TICKETS: Given to tour participants at airport check-in.

PHYSICAL NEEDS: Restrictions may apply; ask for details.
