Program:

Lion's Pride Childcare is a warm, safe and secure learning environment for children from 18 months of age to those ready to begin kindergarten. The program includes daily activities and opportunities for your child to grow, play and explore in an interactive environment that will stimulate development during these early years.

Philosophy:

Our philosophy is founded upon the belief that play is a vital role in each child's physical, social, emotional and academic development. Young children are active participants in learning as they share with us a genuine excitement and love for learning. Teachers foster independence and self-awareness through organized activities and free play.

We value the role of parents as primary caregivers through open communication. The parent/teacher relationship is crucial as we support children and families throughout the year. Lion's Pride is a place where children are valued as unique individuals as they learn through hands-on experiences.

Location:

CommEd Center, 170 Dalton Road, Chelmsford, MA 01824 (Westlands School building)

Times & Dates:

We operate on the school calendar, and are open from 6:30 am to 4:30 pm on the 180 school days, the full professional development day, the teacher workday before school opens, and the day after school ends.

Snow, Delayed Opening

We are not open on days when Chelmsford Public Schools are closed. On delayed openings, our program will open at 8:30, instead of 6:30. If school is dismissed early, we expect that you would pick your child up as soon as possible.

Staff:

The staff consists of a Teacher and a Teacher Aide in each room, all of whom are under the direction of a Supervisor/Teacher. In addition, we occasionally have the services of high school and college students.

Facilities:

Cozy Cubs Room provides care for toddlers from 18 months old until they are eligible to enter Lion's Pride (maximum 9 children).

Lion's Pride Room provides care for children who turn 3 by 10/1/2012 until they are eligible to enter kindergarten in the upcoming school year (maximum 20 children).

Our facilities offer an area for indoor play, use of the cafeteria, gymnasium, and the outdoor playground and field.

Tuition is billed in ten equal payments September through June, and is due on the first day of the upcoming month.

A one-time non-refundable \$10 registration fee is due with the first month's payment.

Curriculum:

Our curriculum provides opportunities for your child to develop motor, language and social skills, and to foster independence. We emphasize a positive, safe, secure learning environment to help the children grow during this special stage of their development.

The children have separate areas for creative play, block area, circle time, writing center, math and science exploration, art, music and sensory play. In addition, we are providing a large room for indoor play on days when weather prevents us from taking the children outside.

Enrollment: Children must be registered for the full school year, the full professional day, and the teacher workdays before and after school starts/ends.

There are no adjustments in the monthly tuition if your child is sick or does not attend for another reason. A parent may terminate his or her child's participation in the program by giving one month's notice to Chelmsford Community Education, 170 Dalton Road, Chelmsford, MA 01824. Where proper notice is given, parents only will be responsible for paying services actually rendered to their child. The monthly fee will be pro-rated to the time that the child participated in the program.

Transportation: Provided by parents.

Lunch & Snacks: In addition to drinks and snacks twice a day, we provide hot lunch for the children, except on early release days when you must provide lunch for your child. The lunches are the same hot lunches that the School Department offers to the elementary schools. You will receive menus in advance. The food we serve has been checked to ensure that it is peanut-free. You are welcome to send a lunch with your child if the offered selection is not to your child's liking or he or she is allergic to the ingredients.

First Aid & Emergencies: A Registered Nurse is scheduled to be on duty from 8:15am to 2:45 pm and treatment will be given to your child as needed. In the event of an emergency, you will be notified immediately. Please be sure to keep your emergency contact information up-to-date.

Late Policy: A late pick-up fee will be assessed at the rate of \$10 for each 15 minutes or portion thereof. Unfortunately, if you are consistently late in picking up your child, you will be asked to find alternate childcare arrangements.

Clothing & Supplies: The following items should be labeled and provided by the parents. An adequate supply is needed at all times because there are no spares available. All items are stored separately for your child. Not all items may be needed for your child.

2 complete sets of clothing, including socks and underwear	Blanket

Proper attire is required for children in order to participate in outdoor cold weather activities. Children may not go outside without warm clothing. Staff will set a good example and dress appropriately. Parents whose children are not dressed appropriately will be reminded to send their children to school dressed correctly for cold weather play.

We are a hands-on classroom. Please make sure you send your child in comfortable clothing that they can play in and get messy. Our playground is covered in bark mulch. We request that all children wear closed toe shoes, preferably sneakers.

Personal Toys: We discourage bringing personal toys to our program, as we cannot be responsible for them. An exception can be made if your child requires a "napping" toy.

Registration: Applications for the Chelmsford Public School's Lion's Pride Program will be accepted on a first-come, first-served basis.

The children have separate areas for creative play, block area, circle time, writing center, math and science exploration, art, music and sensory play. In addition, we are providing a large room for indoor play on days when weather prevents us from taking the children outside.

Enrollment: Children must be registered for the full school year, the full professional day, and the teacher workdays before and after school starts/ends.

There are no adjustments in the monthly tuition if your child is sick or does not attend for another reason. A parent may terminate his or her child's participation in the program by giving one month's notice to Chelmsford Community Education, 170 Dalton Road, Chelmsford, MA 01824. Where proper notice is given, parents only will be responsible for paying services actually rendered to their child. The monthly fee will be pro-rated to the time that the child participated in the program.

Transportation: Provided by parents.

Lunch & Snacks: In addition to drinks and snacks twice a day, we provide hot lunch for the children, except on early release days when you must provide lunch for your child. The lunches are the same hot lunches that the School Department offers to the elementary schools. You will receive menus in advance. The food we serve has been checked to ensure that it is peanut-free. You are welcome to send a lunch with your child if the offered selection is not to your child's liking or he or she is allergic to the ingredients.

First Aid & Emergencies: A Registered Nurse is scheduled to be on duty from 8:15am to 2:45 pm and treatment will be given to your child as needed. In the event of an emergency, you will be notified immediately. Please be sure to keep your emergency contact information up-to-date.

Late Policy: A late pick-up fee will be assessed at the rate of \$10 for each 15 minutes or portion thereof. Unfortunately, if you are consistently late in picking up your child, you will be asked to find alternate childcare arrangements.

Clothing & Supplies: The following items should be labeled and provided by the parents. An adequate supply is needed at all times because there are no spares available. All items are stored separately for your child. Not all items may be needed for your child.

2 complete sets of clothing, including socks and underwear	Blanket
Outer wear	Small pillow
Disposable diapers	Crib sheet
Ointment/powder	Wipes
3 4x6 photos (used to label cubby, etc.)	Sunscreen (optional)

Proper attire is required for children in order to participate in outdoor cold weather activities. Children may not go outside without warm clothing. Staff will set a good example and dress appropriately. Parents whose children are not dressed appropriately will be reminded to send their children to school dressed correctly for cold weather play.

We are a hands-on classroom. Please make sure you send your child in comfortable clothing that they can play in and get messy. Our playground is covered in bark mulch. We request that all children wear closed toe shoes, preferably sneakers.

Personal Toys: We discourage bringing personal toys to our program, as we cannot be responsible for them. An exception can be made if your child requires a "napping" toy.

Registration: Applications for the Chelmsford Public School's Lion's Pride Program will be accepted on a first-come, first-served basis.

CORI Screening: Those individuals having direct and unsupervised contact with children will be subject to mandatory Criminal Offender Registry Information (CORI) screening.
